Project Manager's message

Welcome to the spring edition of the Hills of Gold Wind Farm newsletter.

As we approach the end of 2022, I want to start this edition of the Hills of Gold Wind Farm newsletter by thanking all those community members and stakeholders who have continued to put time into providing feedback into the project. While we understand the growing sense of wanting to know the outcome of the wind farm, it is important that the ENGIE and Someva teams continue to engage and respond to feedback.

As a direct response to stakeholder feedback, the project team has spent the last few months conducting a range of studies to determine changes required to the project, in order to reduce impacts. The most notable change to the project in this amendment is the proposed transport route for all oversize vehicles and some construction related traffic to go via Crawney Road, rather than Barry Road, avoiding the need for a bypass at Devils Elbow and retaining walls on Morrisons Gap Road. Also included is the removal of a turbine and minor relocation of a further 20 turbines to provide a larger buffer along Ben Halls Gap Nature Reserve, a potential new location for the substation and battery storage system, and a new quarry option to reduce trucks travelling on local roads.

Given the changes included in this amendment, a formal public exhibition will be held from mid-November to mid-December, during which time the community can make submissions to the Department of Planning regarding the changes. Following the exhibition period, the project team will work on our responses.

Depending on the nature of the submissions, and if further technical work is required, we are still aiming to have a recommendation from the DPE in the first quarter of 2023, with the Independent Planning Commission expected to be held in mid-2023.

In other news, it's been great to have been able to support a number of local projects and events through our sponsorship program this year. In this edition of the newsletter, we're highlighting the new Foodbank and our support of the Nundle Swimming Club program - both fantastic community initiatives.

Thanks to all those who have taken the time to visit the team at the new Community Hub in Nundle. We hope you agree the facility provides a welcoming and informative space to learn more about the proposed wind farm. It is great to see Susi Rieger working there each Friday, with members of the ENGIE and Someva teams joining her when we're in town.

Finally. I would like to take the opportunity to wish all community members and stakeholders a very happy and safe holiday season, and we look forward to working with you further in 2023.

Project Amendment

Following feedback from Tamworth Regional Council, the Department of Planning and Environment (DPE). National Parks and Wildlife, the community, and input from construction contractors, ENGIE is making a number of changes to the project. These changes are intended to provide more clarity and reduce overall impacts of the project during construction and with ongoing operation.

Summary of the changes

Transport route: An alternative access route proposes delivery of wind turbine components and some general construction traffic to access the wind farm via Crawney Road, rather than the previously proposed Devils Elbow Bypass. While this will create traffic on Crawney Road, minimal impact with no change to the level of service is expected. The change avoids the need to build the Devils Elbow Bypass and retaining walls on Morrisons Gap Road and will reduce the volume of traffic using this route.

Quarry: Expansion of an existing quarry within the Nundle State Forest, is being considered. The quarry is closer to the project than previously assumed sources of material, creating the potential to reduce the number of trucks travelling on local roads, and in particular through Nundle.

Turbine removal / relocation: To create a larger buffer between the project and Ben Halls Gap Nature Reserve, one turbine will be removed, and 20 turbines will be slightly relocated. This has created a 1.2km wildlife corridor and reduced the potential impact to birds and bats to 'low' following all proposed operational mitigations available to the project.

Location of substation and battery storage: If Crawney Road is to be used for construction and oversize vehicles, a potential new location closer to the new proposed route becomes an option. The optional location would be at least 3km from the Teamsters Rest campsite and has been assessed for impacts to those residents living along Crawney Road.

Transmission line: Optional use of tower structures for the transmission line to potentially reduce the height and number of structures required. Also increasing the size of the switching station and some additional access tracks to the transmission line.

ENGIE's Community Sponsorship Program launched in June this year, saw seven groups receive funding towards projects that contribute to the local community. Four months on and program continues to bring benefits to the local community.

The community Foodbank has been operating from the Nundle Hall since August, helping many residents to put food on the table and relieve some of the financial pressure.

Member of The Pot of Gold Community Association and one of the organisers of the Foodbank pantry, Neroli McAulay said, "The Foodbank has been incredibly successful, and we are very grateful for the funding from ENGIE's Hills of Gold Community Sponsorship Program - it has really helped kick start the project."

"The funding from ENGIE meant that we could setup the Foodbank and pay for our first batch of groceries, shopping baskets, registration and insurance costs. We are now proudly self-funded and dedicated to supporting our community and helping take some pressure off the purse strings."

"It's been great to see more people coming through the doors, including families, older residents and people who live on their own. The Nundle Hall provides access for people with limited mobility and wheelchairs, which allows all visitors to access the pantry," said Ms McAulay.

The Foodbank pantry stocks a range of different items, from fresh fruit and vegetables, bread, milk, and pantry staples, through to toiletries, cleaning products and pet food.

"But it's not just the low-cost groceries that keep people coming back. The Foodbank is becoming a popular meeting place for locals to visit, have a yarn and catchup with friends," Ms McAulay said.

"What's most important to our organisation is that we can provide support to the local community, whether that be through the Foodbank pantry, providing a care pack to a local resident whose partner has passed away, or simply bringing people together."

"We've also partnered with our local Anglican Minister and Tamworth Family Support, to help families in need with towels, linen and support services."


The Foodbank operates from the Nundle Hall on Wednesdays from 10am to 2pm and Thursdays from 1pm to 5pm, to help provide the service to a range of people and workers passing through town at different times of the day and week.

Have you visited the Hills of Gold Wind Farm **Community Hub yet?**




The special energy offer will be available once the wind farm is constructed and starts operating.

Local swimmers are set to make a splash in Nundle this season, with Learn to Swim and Development Squad training programs underway
